6. Windsor Estate - Cycle Routes

AE responded to the Crown Estates letter dated 15th June 2018 on 9th August 2018. DP advised that WPC had had a response from the Crown Estate suggesting a meeting date of 1st October 2018.

After much discussion about route PRC3 DP agreed that he would encourage the Crown Estate to adopt this route at the meeting on the 1^{st} October 2018.

• A vote was taken, and it was decided x10 in favour/x2 abstained to REMOVE point 5.30 from the DRAFT NDP.

Policy W12 - Local Gaps

• BS would like within Policy W12 the Local Gap 4 to be included in the Draft Plan. RL suggested we could re-word it appropriately to not contradict the BFC Local Plan.

BS did communicate with Jon Dowty via e-mail to express his concerns over this Local Gap. Jon Dowty responded accordingly, and BS will use Jon's response to draft a few paragraphs to be included into the Draft NDP.

Minerals & Waste, currently under Consultation

• MF suggested it may be a good idea to put a section into our Draft NDP about the Minerals & Waste Plan. DP to talk to JD about this and advise MF. If appropriate MF will draft a few paragraphs.

House Density

• IP raised the subject of medium/large sites and asked could we influence the density of houses in our Draft Plan, could we work this into our Draft NDP?

MG requested that we look at adding a Dark Skies Policy. DP/LC to talk to JD to see if we could add a policy re: Dark Skies into our plan. NA agreed that he would pull this policy wording together.

DP asked that JD add this statement into the WPC NDP to ensure... "that any future development is communicated to the Local Community Groups, NDP and WPC at the very earliest stage." DP/LC to clarify with Jon Dowty that this would be acceptable to add.
