2. Declaration of Interest

3. Minutes of the Previous Meeting

The draft minutes of the meeting held on 11th September 2018, were agreed.

4. Finance and Funding Report

The latest Financial Report was attached to the agenda, noted.

5. Topic Group Reports

<u>Design & Character</u> – HB updated the character assessments, taking out any reference to private houses that were originally put on the Heritage Asset List – as agreed by the Steering Group at the previous meeting on 11th Sept 2018.

<u>Housing</u> – Complete.

Business/Employment – Complete.

<u>Green Infrastructure/Environment</u> – BS has updated the main Green Infrastructure Evidence document to V20 and asked that the Steering Group take the time to read Section 5.5. It was agreed that BS, RS, MF and NA would form a working party to revise The Gap information within V20 of the Green Infrastructure Evidence document. BS also agreed to update the Cycle Route Proposal V18 document to take out PCR.03 and update the associated map.

6. Heritage Assets List

HB advised that the following needs to be done to complete this section:

- approve the heritage asset procedure and form.
- set up a committee with suitable experts in this field VB & DP offered to sit in on this group TVO will forward details to HB of another person who may be able to help. HB to look at other people to sit on this committee.
- fill in forms to nominate assets and submit to committee all SG members to help with this (currently only have a submission for Chavey Down).
- the committee agree whether to approve or decline.

7. Windsor Estate – Cycle Routes

DP updated the Steering Group on the meeting between the Crown Estate and WPC on Monday 1st October.

- DP/AE confirmed that the deputy Ranger was emphatic that they would not consider any further development of the cycle routes on Crown land (the 1961 Government Act in protecting the Estate is fundamental to their operation).
- The Deputy Ranger also confirmed the outcome of the discussions between RBWM and BFC three
 years ago and the only way forward was looking at road safety measures with an aim of reducing
 the speed to improve the safety of cyclists. Any road safety measures are the responsibility of
 the two Borough councils.
- DP/AE also confirmed that any cycle route in our NDP can only make recommendations within the Parish boundaries and not extend into neighbouring areas.

BS asked if DP/AE could get a follow up statement/letter from Paul Sedgewick at the Crown Estate, confirming the discussions from their meeting on Monday 1st October.

BS agreed to update Supplement B: Proposed Cycle Routes through Winkfield Parish document and map within this document to reflect the discussion with the Crown Estate.

Policy W6 - Community Right to Build Orders

An adjustment from the previous minutes - A vote was taken, and it was decided x10 in favour/x2 abstained to REMOVE this Policy completely from the DRAFT NDP. DP expressed his concerns about putting our plan at risk by taking this policy out of the DRAFT NDP.

Policy W12 - Local Gaps

Please see number 5 above – Topic Group Reports, Green Infrastructure/Environment. Also, after much discussion on this subject it was agreed that a small group be formed to re-write this section within the DRAFT NDP. BS, RS, MF and NA to revise the Gap detail and to look at re-wording P16/17 section 3.9 as all agreed headings and emphasis needs adjusting.

DP to feedback BS's updates on the Green Infrastructure Evidence report to Jon Dowty and BFC.

Minerals & Waste, currently under Consultation

Having been advised by BFC and O'Neill & Homer that Minerals and Waste is a 'county matters' and falls within the definition of excluded development in the 2004 Act; the SG agreed they would still like to include this within the DRAFT NDP. DP expressed his concern over the credibility of the plan if Minerals & Waste was added to the DRAFT NDP.

It was agreed that MF and NA will re-write the Minerals and Waste section and it would then be agreed where this section would be slotted into the DRAFT NDP.

Dark Skies Policy

All agreed that the wording NA had produced for this Policy was appropriate and should be added to the DRAFT NDP.
